ARTICLE I - NAME

The name of this corporation is CRAB CROSSING, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 7802 S.E. Canaan Way, Jupiter, FL 33478.

ARTICLE III - DURATION

The effective date of the existence of this corporation shall be the date these articles are executed by the incorporator and it shall exist perpetually thereafter.

ARTICLE IV - PURPOSE



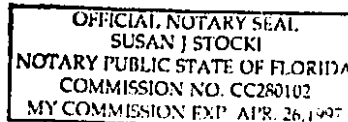
