

# ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

# **ARTICLE 1 - NAME**

# **ARTICLE 2 - PURPOSE OF CORPORATION**

# **ARTICLE 6 - CORPORATE CAPITALIZATION**

- 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE YUNDRED** (7,500) shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).
