**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Professional Service Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I
Name

The name of the corporation is: Coastal Medical Group, P.A.

ARTICLE II
Mailing Address

The mailing address is: 1202 66th Street North, St. Petersburg, Florida 33710

ARTICLE III
Nature of Business

The corporation is organized to engage in every aspect of the business of rendering the professional services to the public that a physician, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees, and agents of the corporation who are duly licensed under the laws of the state of Florida to render services as a physician, and to engage in any and all other lawful business.

ARTICLE IV
Stock

This corporation is authorized to issue One Hundred (100) shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

ARTICLE V
Initial Registered Agent and Office

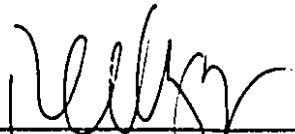
ARTICLE VIII

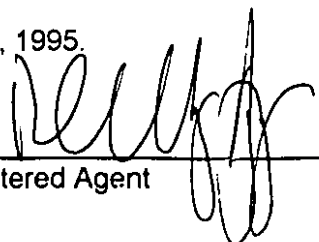
