

ARTICLES OF INCORPORATION  
OF  
J.A.O. ENTERPRISES, INC.

ARTICLE I - NAME OF CORPORATION.

The name of the corporation is J.A.O. ENTERPRISES, INC

ARTICLE II - DURATION OF CORPORATION.

This corporation shall have perpetual existence commencing as of the time that these Articles are filed by the Department of State, Division of Corporations.

ARTICLE III - PURPOSE OF CORPORATION.

This corporation is organized for the purpose of operating a bookkeeping company and of performing the transaction of any or all lawful business for which corporations may be authorized under the Florida Statutes, Chapter 607.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue ONE HUNDRED (100) shares of Common Stock with each share having a Par Value of ONE DOLLAR per share.

ARTICLE V - PREEMPTIVE RIGHTS.

ARTICLE VII - INITIAL BOARD OF DIRECTORS.

ARTICLE VIII - INDEMNIFICATION.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE IX - AMENDMENTS.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendments to them. Any right conferred upon the shareholders is subject to this reservation.
