ARTICLES OF INCORPORATION

OF

The undersigned incorporator hereby forms a Professional Service Corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

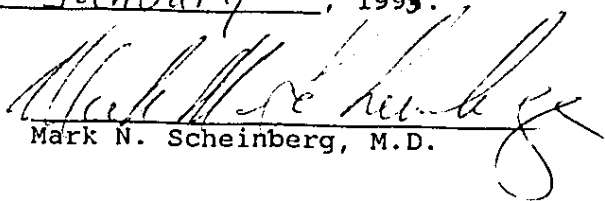

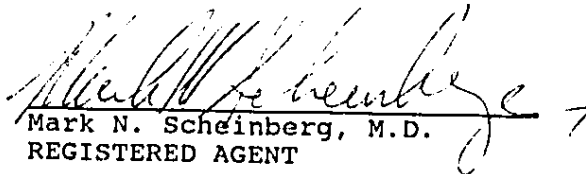
