ARTICLE I - NAME

The name of this corporation is:

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - GENERAL NATURE

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida, including but not limited to the operation of a grocery/deli.
