The undersigned incorporator(s), for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be Jorge M. Rodriguez, Inc. The principal place of business of this corporation shall be: Gulf Gate Mall #270, Sarasota, Florida 34231.

ARTICLE II - PURPOSE(S)
