The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the Corporation is QUANTUM RECYCLED PRINTING AND SPECIALTY ADVERTISING COMPANY

# **ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

# ARTICLE 3 - PRIMA PAL OFFICE

The address of the principal office c. inis corporation is 675 Oak Hollow Way, Altamonte Springs, Florida 32714 and the mailing address is the same.

### **ARTICLE 4 - INCORPORATOR**

#### **ARTICLE 5 - PRESIDENT**

The initial President of the corporation shall be Mary Jane Kampe whose address shall be the same as the principal office of the corporation.



## ARTICLE 6 - CORPORATE CAPITALIZATION

- 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED (7,500)** shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).
