**ARTICLE OF INCORPORATION  
OF

The undersigned subscribers to these Articles of Incorporation, natural persons, competent to contract hereby form and establish a corporation under the laws of the State of Florida with its principal office located at 544 1st Avenue South, Naples, Florida 33940.

**ARTICLE I. NAME**

This corporation shall exist for a perpetual period, commencing at the time of the filing of these Articles of Incorporation by the Florida Department of State.

**ARTICLE III. PURPOSE**

**ARTICLE IV. AUTHORIZED SHARES**

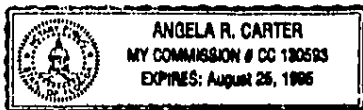
