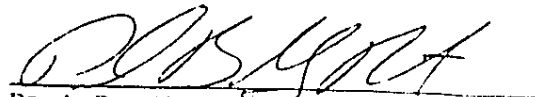

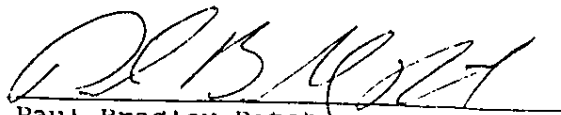
1. The name of this corporation is Bradley Ritch, Inc.
