ARTICLE I

NAME: The name of this corporation is

GULF COAST AMUSEMENTS, INC.

ARTICLE II

DURATION: This corporation shall have perpetual duration.

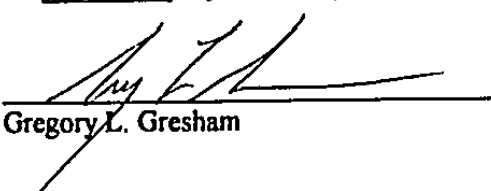
