## ARTICLE I. CORPORATE NAME

The name of this corporation is: HEARING CARE SERVICES, INC., where the principal office is: 3311-66th Street, N., Clearwater, FL 34621.

# ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

## ARTICLE III. CAPITAL STOCK.

## ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE.


