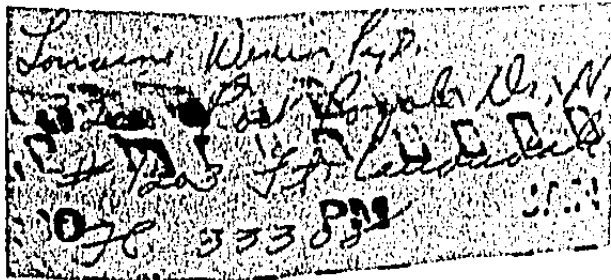

ARTICLES OF INCORPORATION
OF
LORRAINE WINCOR, P.A.

THE UNDERSIGNED SUBSCRIBER to these Articles of Incorporation, being duly licensed to practice Psychology under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporations Act, Chapter 621 Fla.Stat., and other laws of the State of Florida.

ARTICLE I. NAME

The name of the professional service corporation is:
LORRAINE WINCOR, P.A.

ARTICLE II. PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of Psychology. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE III. TERM OF EXISTENCE

The professional service corporation shall have perpetual existence commencing on the date these articles of incorporation are filed with the Department of State of Florida.

ARTICLE IV. CAPITAL STOCK

The capital stock of the professional service corporation shall be one hundred (100) shares of common stock without nominal or par value.

None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice psychology or engage in mental health services in the State of Florida.

ARTICLE V. REGISTERED OFFICE AND AGENT

ARTICLE VIII. RESTRAINT ON ALIENATION OF SHARES

The shareholder(s) of the professional service corporation shall have the power to include in the bylaws, adopted by a majority of the same, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the corporation by any of its shareholder(s), or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions, and details, of the disposition shall be determined by the corporation's shareholder(s); provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock.

No shareholder of the corporation may sell or transfer his/her stock in the corporation except to another individual who is eligible to be a shareholder of the professional service corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting especially called for that purpose. If any shareholder becomes legally disqualified to practice psychology or engage in mental health services in the State of Florida or is elected to a public office or accepts employment that places

restrictions or limitations on his/her continuous rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by its shareholder(s).

ARTICLE IX. AMENDMENT

The corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholder(s) is subject to this reservation.

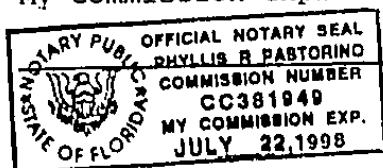
