ARTICLE I

NAME

The name of the corporation is Norris Insurance Group, Inc.  
The principal office address and the mailing address of the corporation is 2702 ROGERS RD., MIAMI, FLORIDA 33133.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of carrying on any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exist and may hereafter be amended.

ARTICLE IV

CAPITAL STOCK

This corporation will issue no par value stock or no par value stock which will be designated as common stock.

## ARTICLE V

### PRE-EMPTIVE RIGHTS

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment thereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.






