ARTICLE I - NAME

The name of this corporation is CANAL TRADING CO., INC.

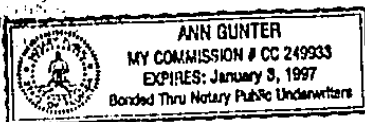
