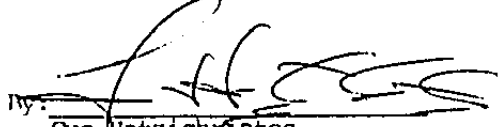

ARTICLES OF INCORPORATION
OF
I.T.O. CORPORATION OF FLORIDA

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act (the "Act").

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is I.T.O. Corporation of Florida.

SECOND: The address of the principal office of the Corporation is 1040 Port Boulevard, Miami, Florida 33132.

THIRD: The mailing address of the Corporation is 1040 Port Boulevard, Miami, Florida 33132.

FOURTH: The total number of shares of stock which the Corporation shall have authority to issue is two hundred (200) shares without par value. All such shares shall be of one class and denominated shares of Common Stock.

FIFTH: The street address of the initial registered office of the Corporation in the State of Florida is 1200 South Pine Island Road, City of Plantation, Florida 33324. The name of the initial registered agent of the Corporation at the said registered office is CT Corporation System.

The written acceptance of the said initial registered agent, as required in Section 607.0501(3) of the Act, is set forth following the signature of the incorporator and is made a part of these Articles of Incorporation.

SIXTH: The name and the address of the incorporator is:

SEVENTH: The purposes for which the Corporation is organized are to engage in any lawful business for which corporations may be organized under the Act.

EIGHTH: The duration of the Corporation shall be perpetual.

NINTH: The Corporation shall, to the fullest extent permitted by the provisions of the Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.
