The undersigned incorporator, DONNIE GENE BARNES, a natural person competent to contract, heroby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is TINKER TOWN, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 7388 Shelby Lane, Pensacola, FL 32526.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue five hundred (500) shares of \$1.00 par value common stock.

ARTICLE V - TERM OF EXISTENCE
