

ARTICLES OF INCORPORATION

OF

SWETA CORPORATION

We, the undersigned, for the purpose of forming a corporation under the laws of the State of Florida as the same may from time to time exist, hereby certify as follows:

ARTICLE I. NAME

The name of the corporation is:

SWETA CORPORATION

ARTICLE II. NATURE OF BUSINESS


