ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is JPS of Via, Inc. (the "Corporation"). The principal place of business and mailing address of the Corporation shall be 2740 U.S. Highway 27 North, Sebring, Florida 33872, or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

The Corporation shall have the authority to issue 10,000 shares of voting common stock, with a par value of \$1.00 per share.

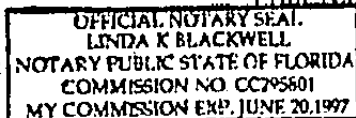

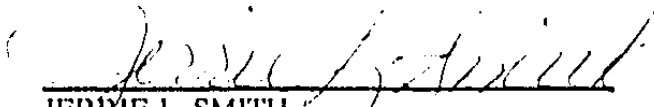

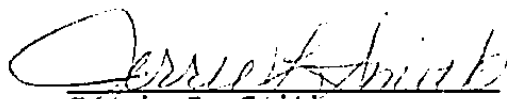
