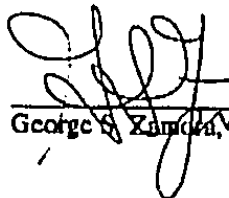
ARTICLE VIII - INDEMNIFICATION

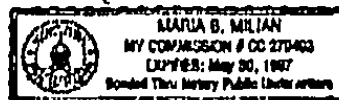
