CERTIFICATE OF INCORPORATION

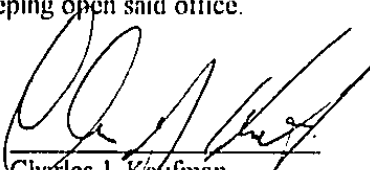
