ARTICLES OF INCORPORATION OF

We, the undersigned subscribers of these articles of incorporation, a natural person, competent to contract and desiring to form a corporation under the laws of the State of Florida, hereby certify as follows:

I

The name of the proposed corporation is:

II

The Corporation shall engage in the business of operating vocational schools as defined by the State Board of Independent Post-Secondary Vocational Technical, Trade and Business Schools under the Department of Business and Professional Regulation of the State of Florida and in any other activity and/or business permitted under the laws of the United States and the State of Florida.

III

The number of shares of stock which the corporation is authorized to have outstanding at any time shall be ONE THOUSAND SHARES WITH a par value of \$500 per share.

IV

The principal business office of the corporation shall be located at 14725 Balgowan Rd. Suite 103, Miami Lakes, Fl., 33016. or at any other such place as may later be designated by the Board of Directors, with branch offices in such other cities, towns, states or countries as may from time to time be authorized by the Board of Directors.

V

The business of this corporation shall be conducted by a Board of Directors which shall consist of not less than one (1) and not more than nine (9) as shall from time to time be designated in by the shareholders of this corporation and a majority thereof shall constitute a quorum for the transaction of all business.

This corporation shall have, in addition to a president, vice-president, secretary and/or treasurer, such other additional officers as may be created from time to time by and under the authorization of its bylaws.

XI



The right of indemnification herein provided shall not be exclusive of other rights to which any such person may now or hereafter be entitled as a matter of law.
