ARTICLES OF INCORPORATION

OF

BIG AL'S LOUNGE, INC.

The undersigned incorporator, being a natural person competent to concract, hereby adopts these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is BIG AL'S LOUNGE, INC.
