ARTICLE I - NAME

The name of the corporation is ELITE PRINTING, INC. (hereinafter called the "Corporation") and the principal office of the Corporation shall be at 16750 N.E. 10th Avenue, Suite 226, North Miami Beach, Florida 33162.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the General Corporation Act of the State of Florida.

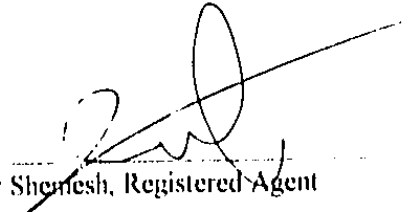
