NAME



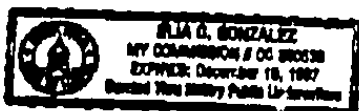
