ARTICLES OF INCORPORATION

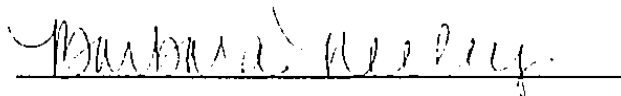

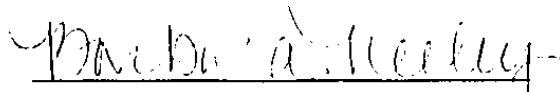
