# ARTICLES OF INCORPORATION OF BAJARIA INVESTMENTS, INC.

The undersigned subscriber to these Articles of Incorporation, is a natural person competent to contract and whom I hereby associate myself with to form a corporation under the laws of the State of Florida.

# ARTICLE I

The name of this corporation shall be BAJARIA INVESTMENTS, INC.

### YELICTE II

The corporation may engage in any lewful business, joint ventures, projects and any other business that is permissible under the laws of the United States and the State of Florida.
