ARTICLES OF INCORPORATION

OF

THE PELICAN PROPERTY MANAGEMENT CIRCLE, 180.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopted the following Articles of Incorporation:

Articles One - Names

The name of the corporation is The Pelican Property Management Circle. Inc.

Article Two - Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article Three - Term of Existence

The corporation shall have perpetual existence commencing upon the filing of these articles.

Article Four - Capital Stock

The corporation is authorized to issue a maximum of Five Hundred (500) shares of One Dollar (\$1.00) per value common stock, which shall be designated "Common Shares". The consideration to be paid to each distributor for each share shall be as follows: Joyce Gonzalez shall have 50% of the shares, Robert Gonzalez shall have 12.5% of the shares; R.J. Steffer shall have 12.5% of the shares; and William Chais shall have 25% of the shares.

<u>Article Five - Preferences, Limitations</u> and Relative Rights of Shares of Capital Stock

Section 1. Dividends:

The holders of record of "Common Shares", if any, shall be entitled to cash dividends when and as declared by the Board of Directors at the rate per share per annum and at the time and in the manner determined by the Board of Directors.

Section 2. Rights upon Liquidation or Dissolution:

In the event of any voluntary or involuntary liquidation, dissolution or winding up of this corporation, after the payment of any and all debts and obligations, the remaining assets of this corporation shall be payable to and distributed ratably among the holders of record of the "Common Shares".

Section 3. Voting Rights:

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding "Common Shares".

Article Six - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or saris as that which he/she already holds, shall have the right to purchase his/her pro rata share thereof, at the price at which it is offered to others.

Article Eleven - Amendment

Article Twelve - Action without a meeting

Any action that may be taken at a meeting of the shareholders of this corporation may be taken without a meeting if consent in writing setting forth the action shall be signed by all, but not less than all, of the shareholders of the corporation entitled to vote on the action and shall be filed by the secretary of the corporation. This consent shall have the same effect as a unanimous vote at a shareholder's meeting.
