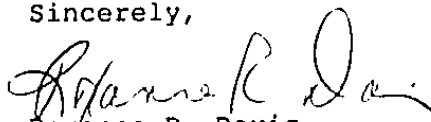

ARTICLE I. CORPORATE NAME.

The name of this corporation is KEY MEDICAL PRODUCTS, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS.
