ARTICLES OF INCORPORATION OF WELLINGTON & REYNOLDS CONTRACTING CORPORATION

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of FLORIDA, adopt the following articles of incorporation:

FIRST

The name of the corporation is:


