ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The name of this corporation is NEW SPACE, INC.

ARTICLE II - CORPORATE EXISTENCE

The existence of this corporation shall commence on the 5th day of January, 1995: provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida law for the commencement of corporate existence. The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is authorized to engage in any lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The capital stock authorized, the par value thereof, and the class of such stock shall be as follows:



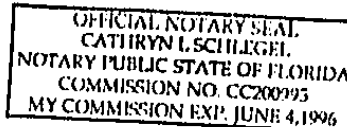
