The undersigned natural person acting hereby as Incorporator of a corporation for profit under the provisions of Chapter 607, Florida General Corporation Act, of the Florida Statues, does hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME OF CORPORATION

The name of this corporation is Rave Investments, Inc. The principal place of business of this corporation, and the mailing address shall be 931 Palm Trail #5, Delray Beach, FL 33483.

ARTICLE II

PURPOSES

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE III

CAPITAL STOCK

- a. The corporation is authorized to issue 1,000 shares of common stock, all of one class, at \$1.00 par value.
- b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.
