ARTICLE I - NAME

The name of this corporation is PRO PEST, INC.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the Laws of the United States and Florida, including but not limited to the ownership, maintenance, and operation of a pest control service company and all activities incidental thereto.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is 1,000 shares of common stock having no par value.

ARTICLE V - INITIAL REGISTERED
OFFICE AND AGENT

The initial registered office of this corporation shall be 205 Airport Road, South, Naples, Florida 33942, County of Collier, State of Florida, and the initial registered agent of this corporation at such office shall be Patrick E. Warner, who upon accepting this designation agrees to comply with the provisions of Florida Statutes as amended from time to time, with respect to

keeping an office open for service of process. The principal office of this corporation is 205 Airport Road, South, Naples, Florida 33942.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of three members. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one nor more than three.
