ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- AVIATION INDUSTRIAL MAINTENANCE 2000, INC.
and whose principal office location is 16608 MEADOW GARDENS ST.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:
CONTRACT REPAIR AND MAINTENANCE OF AIRCRAFT and shall include the
transaction of any and all lawful business for which corporations may be
incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK


ARTICLE IX - POWERS
