ARTICLES OF INCORPORATION OF BASS-O-MATIC, INC.

ARTICLE I

SS FILED

The name of this corporation shall be as follows: DASS-O-MATIC, INC., and the initial principal office of this Corporation shall be: 20801 BISCAYNE BOULEVARD, SUITE 424, AVENTURA, FLORIDA 33180.

The commoncement of existence of the corporation shall be the date of filing.
