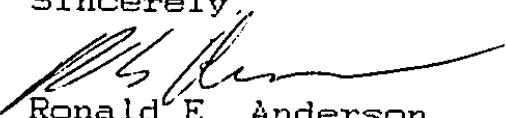

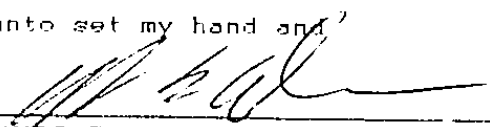
ARTICLE IX. AMENDMENT

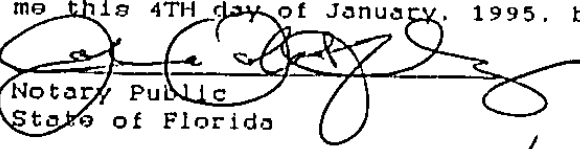
