## ARTICLES OF INCORPORATION





### BAINBRIDGE FINANCIAL CORPORATION

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

### **ARTICLE 1 - NAME**

The name of the Corporation is BAINBRIDGE FINANCIAL CORPORATION

### **ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

### **ARTICLE 3 - PRINCIPAL\_OFFICE**

### **ARTICLE 4 - INCORPORATOR**
