The undersigned, for the purpose of forming a corporation under the law of the State of Florida, do hereby adopt the following Articles of Incorporation:

# ARTICLE ONE

NAME

The name of the corporation shall be:

SEGURO QUE SI INSURANCE, INC.

# ARTICLE TWO

# CORPORATE DURATION

The duration of the corporation is perpetual.

# ARTICLE\_THREE

# PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

### 1. Sell insurance.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares or the capital stock of, or any bonds, securities, or other evidence of indebtedness created by any other corporation of the State of Florida or any other state government, and while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote such stock,
- 6. To engage in any activities or business permitted under the laws of the United States and Florida.
- 7. To do such other things as are incidental to the foregoing or necessary or desirable to order to accomplish the foregoing.


