ARTICLES OF INCORPORATION OF SAL & LINDA, INC.

ARTICLE I. NAME

The name of this corporation shall be Sal & Linda, Inc.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Division of Corporation. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of any legal purpose permitted under the laws of Florida and the United States Of America.

ARTICLE IV. CAPITAL STOCK
