ARTICLE I

The name of this corporation is: OCEAN GROOVE CORPORATION The principal place of business of this corporation shall be at 11900 Biscayne Boulevard, Suite 760, North Miami, Florida 33181.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is to engage in any lawful activity for which corporations may be organized under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number e shares of stock which this corporation is authorized to have outstanding at any one time is One Hundred (100) shares of common stock of Five (\$5.00) Dollar par value.
