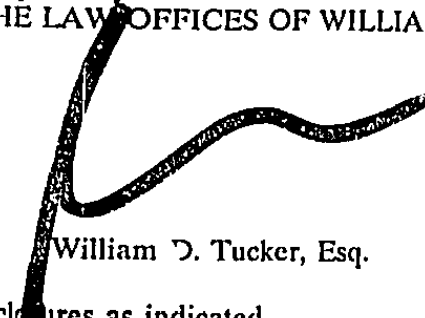
Thank-you for your help this afternoon.

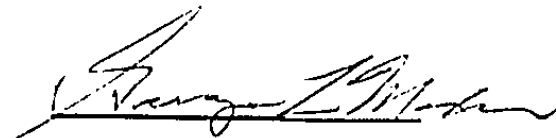

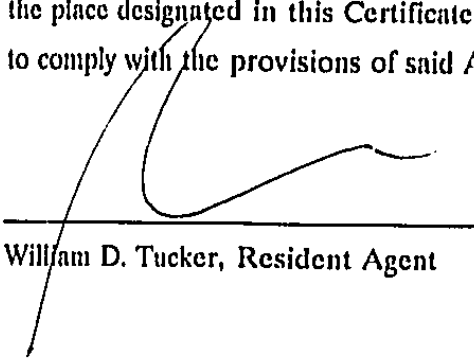
