

ARTICLES OF INCORPORATION
OF
R AND E ENTERPRISE OF GAINESVILLE, FLORIDA, INC.

ARTICLE I - NAME

The name of this corporation is: R AND E ENTERPRISE OF GAINESVILLE, FLORIDA, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of common stock having a par value of One Hundred Dollars (\$100.00) per share.

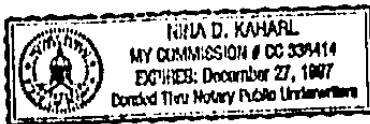
