#### ARTICLE ONE - NAME

The name of this corporation is Michael Griffin, Inc. (hereinafter referred to as the "Corporation").

#### ARTICLE TWO - DURATION

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

## ARTICLE THREE - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business not inconsistent with the laws of the State of Florida.

#### ARTICLE FOUR - CAPITAL STOCK

The Corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock.

The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.


# ARTICLE THIRTEEN - AMENDMENT
