HOLLYWOOD PALMS PLANT NURSERY, INC.

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. NAME: The name of the corporation is HOLLYWOOD PALMS PLANT NURSERY, INC. The corporation's principal and mailing address is 3120 N. 64th Avenue, Hollywood, FL 33020.

2. TERM: This corporation shall exist perpetually. The corporate existence shall commence upon the filing of these articles of incorporation.

3. PURPOSE: The corporation may engage in any legal activity, business or transactions for which corporations may be incorporated under Florida law.

4. CAPITAL STOCK: This corporation is authorized to issue 100 shares of common stock of no par value.


