ARTICLE I

NAME: The name of this Corporation is SECURITY SHREDDING SERVICE, INC., and its address is 652 West Cadillac Drive, Altamonte Springs, Florida 32714.

ARTICLE II

DURATION: This Corporation shall exist perpetually.

ARTICLE III

PURPOSE: The purpose is to engage in any activities or business permitted in the laws of the United States and Florida.

ARTICLE IV

CAPITAL STOCK: The Corporation shall have the authority to issue SEVEN THOUSAND FIVE HUNDRED (7,500) shares, all of one class, ONE (\$1.00) DOLLAR par value.
