ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be as follows:

Thomas K. Rowe, Inc.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The purpose of this corporation is the transaction of any and all lawful business for which corporations may be incorporated in this state.

ARTICLE IV

The total number of shares which the corporation is authorized to issue is one thousand (1000) shares, all of which shall be common shares with par value of \$1.00. All issued stock shall be held of record by not more than twenty five (25) persons. Stock shall be issued and transferable only to natural persons, estates or trusts as described in 26 U. S. C. 1371. No stock shall be issued or transferred to non-resident aliens.

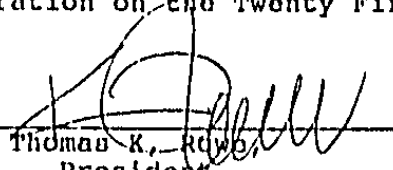

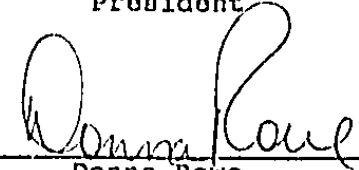

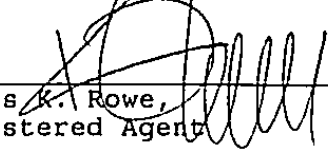
