FOR

The undersigned subscriber to these Articles of Incorporation, natural persons competent to contract, hereby form a Corporation under the Laws of the State of Florida.

ARTICLE I, NAME

The name of the Corporation shall be: David F. Foss, D.D.S., Inc.

ARTICLE II, PRINCIPAL PLACE OF BUSINESS

The principal place of business of this Corporation shall be 3245 Southside Boulevard, Jacksonville, Florida, 32246.

ARTICLE III, NATURE OF BUSINESS
