All the coop papers I gave to our CPA Mr. Griffey, and we asked him to do everything nessary for the coop. He retired this spring. And he and his office didn't receive a bill.

As I told you I am very sorry, but we are from the US and didn't know about the filing with the secretary of state.

When I did my Realestate course two weeks ago I learned that coops have to file once a year with the secretary of state or die. I wondered because I hadn't seen such a filing, I called the office where Mr Griffey was working before and they found out that we had never filed.

I am very sorry about all this and I enclose as you told me the 200 US check with the hope that we don't have to pay the 175 US.
