ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these articles of incorporation, being duly licensed to practice law under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I. NAME

The name of the professional service corporation is LAW OFFICES OF J.JEFFERSON OVERBY, P.A.

ARTICLE II. PUPPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of law. ARTICLE VIII. RESTRAINT ON ALIENATION OF SHARES

ARTICLE IX. AMENDMENT

The corporation reserves the right to amend or repeal any provisions in these Articles of Incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.
