To Whom It May Concern,

Upon the recommendation of one of your agents, by the name of Kristen, I am re-submitting this request for a waiver of the late fee in the hope of clarifying the events that led to this unintentional delay.

In the initial request to your office for leniency, my husband wrote that the documents were inadvertently lost under a stack of paperwork. However, what he failed to tell you was the reason why the annual report, along with numerous other documents and bills, were not handled promptly. He also neglected to tell you that as a result of the situation described below, our business is going through a financial setback.

First, I think it is important for you to you know that this "small business" consists of only 2 people: my husband and myself. So, whenever a family crisis or emergency occurs, the business is immediately affected as it was during the events that led to the filing delay.

Two major life changing events occurred during this period that caused major hardships and shifted our priorities. Not only was our business adversely affected but our family as well.

The first was the sudden, lengthy illness and untimely death of my husband's father who lived in Pittsburgh. As the only son, my husband was responsible to travel frequently to and from Pittsburgh to visit, handle problems, then arrange for funeral services. As a result of his absence and his grief, many things got postponed and our business suffered.

The second hardship came when my Mother was diagnosed with Breast Cancer. I became responsible not only for nursing her after breast surgery but also for taking her for radiation treatments on a daily basis. Since she preferred to stay in her own apartment, 45 minutes from our home, I drove back and forth daily. This went on for six months plus trying to keep the family going. In the midst of this turmoil, many aspects of our business were unintentionally

overlooked. Once again, our business suffered.

When things finally began to settle down we discovered our business had taken a very big loss. We have been making every effort to catch up on past debts as well as trying to generate new business so we can remain solvent.

At this time, not only will the \$400 late fee increase our existing debts but it will also add to the hardship we are experiencing in our efforts to restore our business as well as our family to good health. We hope that the Florida Department of State, Division of Corporations will review our circumstances favorably so we can recover as quickly as possible.

As directed, enclosed you will find a check for \$150. We thank you for your consideration and please accept our apology for any inconvenience our delay may have caused you.
